- PDF portfolio with images and examples of 2 10 public realm artworks created in the past five years that also explains commission process if applicable i.e.: community engagement, part of a festival program, etc.
- Artist statement (maximum 300 words)
- Skills statement (maximum 300 words)
- Links to creative practice digital platform

#### Please note:

- This EOI process aims to identify and engage creative practitioners who have not been commissioned by Hobsons Bay City Council in the past 5 years.
- Applicants must have the capacity and expertise to complete Street Art projects within Hobsons Bay prior to August 2025.
- Applicants are not guaranteed an opportunity to deliver a Street Art project.
- Shortlisted applicants will need to meet with Council representatives to discuss potential project concepts and sites prior to a formal agreement being made.
- Hobsons Bay City Council will not be responsible artists travel and accommodation costs if applicable.

# Expressions of Interest (EOI) can be submitted before 3pm Friday 13 December 2024.

#### **Eligibility**

- Artists over the age of 18 at time of entry
- Artists that have not been commissioned by Hobsons Bay City Council to undertake a Street Art Project in the past 5 years.

Applicants will be assessed by a panel against the following:
